- Most contractors choose the Limited Company option which involves incorporating a company. OSK will need the following:
  - a. Company name
  - b. Details of company director and company secretary
  - c. Registered office address and trading address
  - d. Once incorporated OSK will then register the company for corporation tax, VAT and PAYE

## **Contracting in Ireland from overseas**
